The Normal West Concert Winds, Symphonic Band, and Symphonic Winds will travel to Gurnee, IL on Saturday, May 15, 2010 to perform at the Six Flags Great America Music in the Parks Band Festival.

Student Costs Include: school bus transportation, festival entry fees, and admission to Six Flags Great America. Meal costs are not included.

The total cost is \$60 payable as follows:

Payment 1: \$30 due on Friday, January 29, 2010

Payment 2: \$30 due on Monday, March 15, 2010

After Monday, March 15, 2010, payments are non-refundable in the event of cancellation.
